#### **New Business**

**Special Exception – Lisa Duschl:** 7 Conestoga Avenue, Ephrata. Applicant is requesting a Special Exception to §184-12 to operate a dog grooming business out of the home. A motion by Miller second by Howard to allow the Special Exception request of Lisa Duschl of 7 Conestoga Avenue to be approved by the Zoning Hearing Board as submitted. Motion carried.

**2021-05** Agriteer (MM Weaver) Preliminary/Final Subdivision and Land Development Plan: 391 E. Main Street, Leola. Zoned Ag, Commercial & residential. Applicant proposes a modification to the plan that was approved by the Board of Supervisors on February 13, 2023. Agriteer wishes to add 15 additional employees and the added space to the building would allow for this. A motion by Renehan, second by Frazier to recommend approval of the Agriteer (MM Weaver) Preliminary/Final Subdivision and Land Development Plan based on Township Engineer's letter of April 15, 2023 with the recommendation that the developer investigate the northern access lane that connects to Butter Road to ensure that the driveway has suitable width to allow farm equipment to pass.
