Akron Borough Water Capacity

- No formal request for bulk water supply received.

Old Business:

- Hillcrest Pool: Question was raised at the September meeting as to who serves the pool.

Dale Kopp reported, according to Township records, an agreement was executed on January 5, 2004 for West Earl to serve the Hillcrest Swim Club with water. The bill for the swim club is sent directly to Akron Borough. The pool is located within the Borough of Akron but the parking lot is in West Earl Township.

Ridge Property Holdings (498 South 9th Street & 415 South 7th Street): Question was raised at the September meeting as to whether the developer ever purchased water capacity. Dale Kopp reported that the developer never purchased water capacity, however there is an escrow balance of \$3,700.

The Water Authority would like the Township to prepare a letter (to be signed by Phil Machonis) to the developer informing them of the remaining balance.
