- Quote from Rettew for the Non-Motorized Sidewalk/Transportation Plan The plan will be funded with grant money in total of \$21,000 by the Walk Works Grant and the DCNR Peer to Peer grant. Rettew's quote for preparing the plan is \$17,971.00. Vice Chairman Keppley requested that he be notified ahead of time if there will be any additional costs. Moved by Member Thornton, second by Vice Chairman Keppley to approve Rettew's quote for the Non-Mortorized Sidewalk/Transportation Plan. Thornton-yes, Keppley-yes, Stover-yes, Kauffman-yes, Ford-no. Motion passed with a 4 to 1 vote.

Main Street up to specifications per the Land Development plan. Becker has recommended that \$575 of the Letter of Credit be released and \$3,938 be held.
