What is Stormwater?

Stormwater is rainwater and melted snow that runs off street, lawns, and other sites. When stormwater is absorbed into the ground, it is filtered and ultimately replenishes aquifers or flows into streams and rivers. In developed areas, however, impervious surfaces such as pavement and roofs prevents precipitation from naturally soaking into the ground. Instead, the water runs rapidly into storm drains, sewer systems, and drainage ditches and can cause:

- Downstream flooding
- Stream bank erosion
- Reduced water quality
- ♦ Changes in the flow rate of a stream
- Infrastructure damage
- Contaminated streams and rivers

What is an illicit discharge?

An illicit discharge is any discharge to a storm drainage system or waterway that is not composed entirely of stormwater. Our stormwater facilities and waterways are not designed to accept or treat anything but stormwater, and non-stormwater materials, such as residential wastewater or chemicals, will damage the facilities and the environment. The Township has the authority to pursue violations. Activities such as firefighting, irrigation, and residential car washing are not considered illicit discharges.

What can I do to help?

- Maintain stormwater facilities that are on your property.
- Keep leaves and sticks out of storm inlets before and during rain events.
- Do not dump grass, leaves or other debris in swales or streams
- Do not dump chemicals down your drain or in your yard.
- Report illicit discharges to the Township.
- Properly dispose of pet waste.
- Limit the use of pesticides, herbicides, and fertilizers. Use nontoxic organic alternatives whenever possible.

Managing stormwater on your property will not only help protect local streams, but will also help clean up downstream waterways including the Chesapeake Bay. For more information please visit the Township's "Stormwater Runoff Resources" page at

PA Drug Take Back Program

The Pennsylvania Prescription Drug Take-Back Program focuses on alleviating the health and safety concerns from the diversion and abuse of prescription medications by helping our communities properly dispose of unused prescription medications.

The Department of Drug and Alcohol Programs (DDAP) in partnership with the Pennsylvania Commission on Crime and Delinquency (PCCD) and the Pennsylvania District Attorneys Association (PDAA), will work with local communities to provide grants that facilitate the installation of hundreds of secure and permanent prescription drug drop-off boxes installed throughout Pennsylvania.

Preparing items for disposal at a Take-Back Box location

- All pharmaceutical drugs that are being disposed of need to be in a sealed container such as the original bottle or a zip-lock bag.
- Liquid pharmaceuticals should remain in the original container.
- Personal information should be removed or blotted out with a permanent marker.

Items Accepted

- Prescription and over-the-counter solid medications
- Tablets and capsules
- Pet medicines

Items NOT Accepted

- Intravenous solutions
- Injectables, syringes, and needles (i.e. EpiPens)*
 - ~These items should be taken to a health care professional's office or to a hospital for proper disposal.
- Hydrogen peroxide
- Compressed cylinders or aerosols (e.g., asthma inhalers)
- lodine-containing medications
- Thermometers
- Alcohol & illicit drugs (i.e. marijuana, heroin, LSD, etc.)

Reminder to East Main Street

Please make sure that any shrubbery or bushes along side-walks are properly trimmed. Shrubbery or bushes that protrude onto the sidewalks can cause a hazard.



Winter Storm Safety

The winter season is upon us and the Road Department would like to remind you about the general policy for snow removal. Each winter storm event

could be cause for change however.

The major roads are attended to first with the residential streets following. Salt and anti-skid material is spread onto the roadway at the onset of the storm. When the snow accumulates to around 3 inches, the center of the road will be plowed one pass in each direction. This process may take place a couple of times throughout the duration of the storm. As the storm ends the plow will return to widen the street to its full width. Keep in mind that if you clear your driveway or sidewalk there is a possibility of snow getting onto those areas that you have cleared.

In our attempt to clear the snow from the roads, plowed snow occasionally damages mailboxes and plastic fences. Wet, heavy snow and slush increases the chance for damage to occur. To reduce the potential for damage to your mailbox please make sure that it is tightly secured on a solid post. Residents are reminded that mailbox damage occurring from the plowed snow is the responsibility of the property owner. The Road Department will make every effort to avoid causing any damage.

Additional reminders during snow events:

- Do not push or blow snow onto the roadway. This creates hazardous driving conditions.
- Please park vehicles off the street whenever possible. When the crew has done the widening of the street, they will not return to clear parking spaces.
- It is recommended that you wait to clear your sidewalk until after the crew has widened the street. This will prevent the need for additional shoveling of the sidewalks.
- Drive carefully on snow and ice covered streets.

SNOW AND ICE REMOVAL

The Township has an ordinance in place that gives snow and ice removal guidelines for residents of properties located within the Township.

Properties that adjoin a sidewalk.

Residents of properties that adjoin a sidewalk are responsible for removing snow and ice from the sidewalk. A path of at least 24 inches in width must be cleared. If the snow and ice has become too hard to remove, non-skid or abrasive material must be placed onto the sidewalk in order to make it safe for travel. This must be done no later than 24 hours after the snow has stopped falling.

Snow and ice removal from roofs.

It is the responsibility of residents of properties in the Township to remove snow and ice from their roofs in order to prevent it from falling onto sidewalks or streets. This must be done no later than 24 hours after the snow has stopped falling.

Thank you for helping to keep the streets and sidewalks safe for residents.

- ♦ Keep your gas tank full.
- ♦ Slow down and increase following distance.
- ♦ Avoid sudden stops and starts.
- Beware of roads that may look wet, but are actually frozen, often referred to as "black ice".
- Use extra caution on bridges and ramps where ice can often form without warning.
- Carry a cell phone.
- Remove ice and snow from windows, mirrors and all vehicle lights as often as needed.
- Do not pass or get between trucks plowing in a plow line (several trucks plowing side by side).

Sanitary Sewer Expansion

Municipalities are required to identify areas that are in need of public sanitary sewer service. The condition of existing on-lot disposal systems and the water quality of privately owned drinking water wells are important factors in determining where public sanitary sewer service needs to be extended.

West Earl Township has identified *The Conestoga View Area* as an area in need of public sanitary sewer. This project area is generally comprised of North Conestoga View Drive, South Conestoga View Drive, White Street, Dogwood Drive, a portion of Millway Road and a portion of Oregon Pike.

The Authority will initiate the planning and design of the sanitary sewer extension project in early 2016. The first step in the project planning process is to conduct a topographical field survey to document existing conditions. As the project schedule currently stands, the Authority anticipates completing the planning, state permitting and design for the project in 2016. Construction is anticipated to begin either late 2016 or early 2017, and be completed in late 2017.

The Authority will hold public meetings for impacted property owners during the course of the project and will be able to provide more information to property owners after field survey information has been obtained and after preliminary design alternatives are evaluated.
