- Quotes: Underwater Inspection Services \$2,200, and MBA \$4,500.

PPL Temporary Workspace Agreement – Hilltop Tank Location

- Purpose storage area for upgrades to distribution lines, 2 years, starting March 1, 2024.
- Discussion
 - Send agreement to Solicitor for review.
 - It appears an NPDES permit has been obtained.
 - Jeff believes PPL does not have the right-of-way agreements for this general tank site area.
 - Underground piping on tank property needs to be marked out.
 - Request Entech to review existing tank site plans.
 - Payment to WEWA \$250
 - o Expenses by WEWA for Engineering and Solicitor shall be reimbursed by PPL.
 - Concerned about potential construction/work impact to neighborhood (for 2 years).
 - o Authority requests more information on the site and daily activities.
 - Does the work require Twp approvals?
 - o Depending on the impact of the project, could PPL present the project to the Authority.
- Action Items
 - o Send Agreement to Solicitor
 - Entech to review tank site plans against PPL proposed construction.
 - Entech to contact PPL and obtain more details on the proposed work.

Engineers Report

- East Main Street Curb and Sidewalk
 - Entech receives final plans for the project.
 - o Entech Comments
 - Entech or Inframark to be invited to pre-construction meetings.
 - Inframark to inspect curb boxes. Inframark to provide new curb boxes to contractor to replace those that are broken.
 - o Action Items
 - Entech to find out schedule on the start of work.
- Lead Service Line Inventory
 - Entech presented a power point on the new EPA Lead and Copper Rules.
 - All , water system must submit a service line inventory, identifying services lines as: Lead, Non-Lead, Galvanized Requiring Replacement, Status Unknown
 - o DUE DATE: October 16, 2024
 - The verification is very specific on what is an approved method to determine the service line material.
 - The information must be entered into a DEP database (or DEP approved database).
