SOURCES OF WATER:

The Nolt Well located north of Turtle Hill Road and surface water from the City of Lancaster – primarily from the Susquehanna River Water Plant.

Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. ABOUT FLOURIDE: The ideal fluoride content in drinking water is .7 to 1.2 ppm. The water from the Nolt well contains very little fluoride and none is added to that water. However, the water that the Township receives from the City of Lancaster does contain some fluoride. Therefore, residents of West Earl Township receive a mixture of non-fluoridated and fluoridated water.
